



Senior School Student Phone Agreement Form

Purpose:

The purpose of this agreement is to outline the terms under which senior school students are permitted to bring mobile phones to school. This permission is specifically granted for the sole purpose of booking transportation services such as Careem, Uber, and RTA taxis.

Terms and Conditions:

Phone Usage

Students are allowed to bring their mobile phones to school exclusively for the purpose of booking transportation services at the end of the school day in the designated phone-use area. Any other use of the phone during school hours is strictly prohibited. The phone must be switched off throughout the school day and handed in to their form tutor to be securely kept for the whole of the school day.

Transport Booking

Students may use their phones only to book transport via Careem, Uber, or RTA taxis.

No Other Usage

The use of mobile phones for any purpose other than booking transport (e.g., social media, games, calls, messaging) is not allowed during school hours.

Responsibility

Students are responsible for the safekeeping of their phones in their lockers. The school will not be liable for any loss, damage, or theft of mobile phones.

Confiscation

Any student found using their phone for purposes other than booking transport will have their phone confiscated by their Head of Year. The Head of Year will return the phone directly to the student's parent/guardian at the end of the school day. Further disciplinary actions may be taken as per the school's policy.
